New York State Bail Reform



Timeline of Pretrial Procedure Reforms

2019 bail law (eff. Jan 1, 2020) – first major reform to bail statutes since 1971

- Release required, except for certain qualifying offenses (primarily violent felony offenses)
- Non-monetary conditions added as an option for defendants charged with release required or bail qualifying offenses where a "risk of flight" is present
- Required consideration of a principal's "individual financial circumstances"
- Required that any use of a questionnaire, instrument, or tool by a Pretrial Services Agency adhere to specific guidelines.

2020 amendments (eff. July 2, 2020) - Expanded the list of qualifying offenses/circumstances

- Several nonviolent felonies added to the list of qualifying offenses
- Felony arraign while on probation/parole
- Possible persistent felony offender
- Harm to harm provision
- New Non-Monetary Conditions: counseling, treatment, intimate partner violence programming, maintaining employment or school attendance; measures regarding victim safety
- New Data Tracking and Public Reporting Requirements: breakdowns by charge, criminal history, race, ethnicity, gender

Timeline of Pretrial Procedure Reforms

2022 amendments (eff. May 9, 2022)

- New Release Conditions: mental health assessment and evaluation.
- Added specific gun offenses
- Defined "harm to property" to exclude instances where the offense is "negligible" and not intended to further criminal activity

2023 amendments (eff. June 2023)

- Replaced the "Least Restrictive Condition" Standard: Judges must base their conditions on the "kind and degree of control or restriction necessary to reasonably assure the principal's return to court"
- Adding Cash Bail PLUS Non-Monetary Conditions Option: judges can order someone to be detained
 pretrial pending payment of bail and, if bail is paid, they will be subjected to non-monetary conditions
- <u>Specifying Mental Health and Drug Treatment:</u> specified these forms of "treatment" under the programming available via mandatory programming; judges can refer people to crisis stabilization centers
- <u>Expanding Considerations when Addressing Noncompliance:</u> clarified that Judges can set bail or bail and non-monetary conditions in response to non-compliance
- Adding New Data Reporting Requirements: requires OCA to provide monthly data on pretrial jail commitments

Qualifying Offenses

Violent Felony Offenses

Except Robbery 2nd, Burglary 2nd if NOT in the living area of a dwelling

Class A Felonies

• If a PL 220 Drug felony, must be Class A-I (CPCS -1st, CSCS -1st, Operating as a Major Drug Trafficker)

Gun Felonies

CPW On School Grounds, CPW -3rd, Criminal Sale of a Firearm to a Minor

<u>Misdemeanors</u>

- Sex Offenses
- DV offenses Criminal Contempt and Criminal Obstruction of Breathing or Blood Circulation
- EWOC if the individual is required to be registered as a Level 3 Sex Offender
- Bail Jumping -3rd & Escape -3rd



Qualifying Offenses

Non-Violent Felonies

- Incest & Sex Offenses
- DV offenses Criminal Contempt & Unlawful Imprisonment -1st
- Witness Intimidation & Tampering
- Conspiracy to Commit Murder
- Money Laundering in Support of Terrorism
- Offenses involving Sexual Performance by a Child
- Assault -3rd & Arson -3rd as a Hate Crime
- Vehicular Assault -1st & Aggravated Vehicular Assault
- Aggravated Assault Upon a Person Less Than 11 Years Old

- Financial Crimes: Grand Larceny -1st,
 Enterprise Corruption, Money
 Laundering -1st
- Failure to Register as a Sex Offender (Level 3 Offenders only)
- Bail Jumping & Escape
- Sex Trafficking



Qualifying Offenses

Broad Categories

- Any crime causing the death of another person
- Any felony committed while serving a sentence of probation or parole
- Any felony where the defendant qualifies for sentencing as a persistent felony offender
- Any felony or Class A misdemeanor involving harm to an identifiable person or property
 OR Criminal Possession of a Firearm that occurred while RELEASED on a felony or Class
 A Misdemeanor (or while awaiting arraignment on a DAT) involving harm to an identifiable
 person or property OR Criminal Possession of a Firearm






NYC and Non-NYC Unsentenced Jail Population






Lower Court Arraignments by Severity Non-NYC City and District Courts




Non-NYC: Biggest change for non-violent felonies


Cash bail set increased over time; less low-level bail



NYC: Time to disposition at pre-reform levels





Percentage of Pending Cases and Median Days to Disposition Non-NYC City and District Courts





NYC Firearm arraignments: Releases decreasing since 2020 peak





Demographics of Individuals Under NMR




Demographics of Individuals Under NMR*NYC

Funding for Pretrial Services Agencies



"Each pretrial service agency certified by the office of court administration pursuant to this section shall at the end of each year prepare and file with such office an annual report..."

- Warrants
